## SUPPLEMENTARY REGULATIONS

**1: Announcement:** The Witley and District Motor Cycle Club will hold an open trial under the jurisdiction of the Auto-Cycle Union, the ACU National Sporting Code, Environmental Code, Standing Trials Regulations, and the TVTC Group Trials Standing Regulations, these Supplementary Regulations and any final instructions issued.

**2: Eligibility:** Open to licensed members of the ACU driving solo & sidecar trials motorcycles.

**3: Insurance:** The cover for this event will be PREMIER (public liability limit £40m)

**4. Entries:** Enter online at [www.ride-ACU.uk](http://www.ride-ACU.uk) prior to the event or enter on the day. Entry fees are set at **£25 Adults, £30 Sidecar, £15 Youth.**

Open forthwith, close on the day. **All entrants must show ACU licence at signing on.** Cheques payable to **Witley & DMCC.**

**Medication:** It is your responsibility to declare at signing on if you are on medication.

**6: Course:** 3/4 Laps of 12/15 Sections, without roadwork. A Special Test may be used to decide ties. **7:**

**Refuelling Area: It is a condition of entry that the refuelling of all motorcycles must only take place in designated refuelling area. Spillage mats will be provided and must be used.**
